Reports by Officers

- **Police Chief Tony West**: Officer West reported a harassment call, ordinance violation, and a stop sign violation. Noah is not fully on his own yet but is doing some alone time.
- **Director of Public Works:** Matt Presswood report they have the patch machine out and have started working on areas around the schools. The junk drive went well this year with all dumpsters being delivered and on time. Demolition on the Vinegar Hill property did not start off well. The company wants to back out now. They have had problems with Craig Eimer. Matt said he has had all three parties and several meetings prior to the demo start date to make sure they were all on the same page. Craig had called Mayor Bobell last week concerned about insurance and the company doing the job. After further discussion demolition is on hold until we get legal advice from Jordan Klein.
