- Police Chief Tony West: Chief West reported he has been working on ordinance violations. He has been working on a sexual harassment case a couple of weeks ago. New Business: Pamela Erlenbush did not attend the meeting. Mayor Bobell stated Paula sent a letter out for the new trees planted. They will go with Hilltop Nursery again for the next round of trees purchased. Paula stated the trees were paid for in November, delivered on May 6th, and planted in two-three days. Some are not doing so well but there is a one-year guarantee on them.

Monies for the demolition of 104 S. Washington and Vinegar Hill needed moved to the Business District Funds. This does not include the cost of shoring up the wall.

Other Business: FarmFED will have their ribbon cutting ceremony at 6:00p.m. during 2nd Friday on the Square this weekend.

Mayor Bobell had a phone conversation with Ameren regarding grant funding for charging stations. There is one person in town that is interested in getting them. The meeting will be held June 17th at 4:00pm.

John Aylesworth commented on how nice the ballpark looks. He wants to know if they are still planning to put up a new building. Matt Presswood contacted an engineer, and they want \$90,000 in fees to draw them up. Jodi Deibert has the plans from the building at Veteran's Park that is close to what they would like to put up. Matt Presswood is to check and see if the engineers would use those for a lesser fee. The building will be fully blocked. Mayor Bobell would also like more of an overhang so people can get under when it rains. Dee Howard said the EDPB has been rolling over their money waiting on them to move forward. As for a batting cage, they are looking at around \$80,000 for one. The city will not pay that much for one. The city can put a 2-bay cage reusing the netting, concrete, and turf doing most of the work themselves.

Public Comments: The theme for 2nd Friday on the Square is Rodeo with the Community Band playing from 6-7:00pm and Tyler White playing from 7-9:00pm weather permitting.
