## **Reports by Officers**

• **Police Chief Tony West**: Officer West reported there was an inoperable vehicle that has been taken care of. Rise Broadband wants to do more soliciting in town. He isn't sure how often they want to come if it's just once a month over several months or what. Mayor Bobell is not a fan of long term. Officer West said the ordinance states you must sign in at city hall and pay a fee each time. The council wants to keep the ordinance as is.

• **Director of Public Works:** Matt reported the leaf collector broke down last week, but they are close to being done. While they are waiting for parts to come, they are getting the snow equipment ready. Matt has gotten the results of the asbestos testing on the Vinegar Hill building and sent those reports to both parties that sent bids in. There is asbestos throughout the building. Matt has scheduled testing on the property of 104 S Washington.

• **Treasurers Report:** Dee gave the treasurers report. The IMRF fund CD is up for renewal. She said Longview has the highest rate of 5.5. It can be locked in for 90 days or longer. Council would like a year.

Old Business: There are no updates on the Vine Street sidewalk project.
